Public Law

Our master of law program tends to produce qualified bachelors who posses a legal expertise for responding a social need. This law program can be divided into 3 sub-programs, such as,

- Criminal law which is focusing on studying of an advanced criminal law for creating personnel who possesses a criminal law knowledge responding to judiciary organization and other public services
- Business law which is responding to a business sector and any other related works and
- Public law which is aimed at creating personnel with an expertise in public law for responding to an expansion of organizations relate to administrative law for example, the administrative court and other related public services

Admissible number for each program: 25 students Total 70 students The total credits for all course work is 48 credits

Our master of law program is divided into 2 Plans :

Plan A : This Scheme consists of coursework from a list of courses offered and a thesis

Plan B : Students can complete all coursework from a list of courses offered and independent research within 2 year-semesters. After having graduated from our law program, students are eligible to take the examinations for judiciary officers and public prosecutors in accordance with the regulation of judiciary commission and the public prosecutor commission.
